

CONTEST RULES

"SUPER JEU DE L'AVENT by Supermiro"

ARTICLE 1: ORGANIZER AND GAME PRESENTATION

Supermiro (hereinafter referred to as "the Organizer") is a brand of **SPMO SA**, headquartered at **8 rue des Trois Cantons, L-8354 Garnich**, organizing a free contest titled "**SUPER JEU DE L'AVENT by Supermiro**", from **December 2, 2024, to December 25, 2024**.

The contest takes place on two platforms:

Every day at **10 a.m.**, a prize will be offered in partnership with a different partner. The draw to select the winner will be conducted the following day at **4 p.m.**

ARTICLE 2: ELIGIBILITY

The contest is open to any adult residing in France, Luxembourg, Belgium, or Germany, excluding employees of Supermiro and its partners.

Participation is free and limited to one entry per person per contest day. Any attempt at fraud will result in immediate disqualification.

Supermiro collaborates with partners to compose the prizes.

How to participate:

1. **On Instagram:** Follow [@supermiro_](#) and the partner's account, like the daily post, and comment by tagging a friend.
2. **On the website:** Fill out the participation form (first name and email + optional Instagram handle) and click "I AM IN."

Invalid, unreadable, or incomplete email addresses and/or failure to accept the contest rules will result in automatic disqualification. The Organizer reserves the right to conduct any necessary checks. The Organizer is not responsible for corrupted, non-openable, or non-transmittable files.

ARTICLE 3: PERSONAL DATA

By filling out the online form, participants automatically subscribe to Supermiro's **newsletter (Le Média)**. Collected data (first name and email) are strictly confidential and will never be shared with third parties.

In accordance with the General Data Protection Regulation (GDPR), participants have the right to access, correct, and delete their personal data by emailing dataprotection@supermiro.lu.

ARTICLE 4: DRAW AND PRIZE DELIVERY

The draw will be conducted daily at **4 p.m.** by the Supermiro team.

The winner will be contacted:

- By **private message on Instagram** if they entered via this platform.
- By **email** if they entered via the website.
- Via a **public Instagram story** on Supermiro's account.

If the winner fails to:

- **Accept their prize within seven (7) days** of being contacted via email;
- **Provide the necessary information** for prize delivery within the same seven (7) days,

the prize will be considered forfeited.

Prize delivery methods (depending on the prize):

- **Pick-up at Supermiro's office:** 38, route d'Esch, L-1470 Luxembourg.
- **At the partner's location** offering the prize.
- **Sent by email** for digital prizes.

The prize is non-exchangeable, non-transferable, and cannot be redeemed for cash or any other value. No financial or other compensation will be provided if the winner refuses the prize.

ARTICLE 5: LIABILITY

Supermiro disclaims all responsibility for platform malfunctions that prevent participation or the selection of winners.

The Organizer reserves the right to cancel, modify, or postpone the contest in the event of force majeure.

ARTICLE 6: ACCEPTANCE OF THE RULES

Participation in "**SUPER JEU DE L'AVENT by Supermiro**" implies full acceptance of these rules.

The Organizer reserves the right to shorten, extend, modify, or cancel the contest if circumstances require it. Its responsibility cannot be engaged as a result. This also applies in the case of fraud, particularly via IT systems, during participation or winner selection.

In such cases, the Organizer reserves the right to withhold the prize from the fraudulent participant and exclude any participant suspected of fraudulent behavior without prior notice. The Organizer may block any participant who compromises the contest's administration, security, fairness, or integrity and may pursue legal action if necessary.
